# Nature Positive Pledge - Health Check / Verification 2025

Dear colleagues,

As part of the Nature Positive Pledge, you have committed to reporting on an annual basis the progress towards your pledge. Most importantly, we encourage you to communicate your progress to your stakeholders through your usual communication channels such as your university website, around campus and through newsletters etc. We also ask you to complete the short questionnaire below to help us track the progress of our programme. We will not share this information publicly, but we will make an anonymised summary of progress of NPU universities towards their pledges. It is a good opportunity for you to provide any feedback or suggestions for the programme. Please note, only one response is required per institution.

The deadline to complete the form is: **30th November 2025**.

This year for the first time, we are piloting an optional **Verification** service whereby we check your progress (initially through information provided in this form) towards nature-positive outcomes. During the first year of piloting this service, the cost is heavily subsidised and will be **£1000\* GBP** with a **discount available for lower income institutions**, with verification lasting for a year. This will help support core running costs of NPU. If an institution signs up for this service in 2026, then we can guarantee the pilot price for 2 years. The verified institutions and their activities will be spotlighted on the NPU website and will be provided with a badge which can be added to institutional websites and communications.

We are also developing our **Nature-positive training** for staff and **Biodiversity Footprinting pilot**, both of which will launch in 2026, and we will be sharing more information on these soon. Thanks to all of those who have expressed interest to date.
